## 2022 STAFF CODE OF CONDUCT

- \*I will follow the Scout Law, Scout/Venture Oath, and Outdoor Code, and I will remember that these are the basis for all the following rules and should be the basis for all of my actions.
- \*I will set a good example by keeping myself neatly dressed and presentable. The official Scout uniform is the only acceptable apparel on the first day, flags and during my presentation. The NYLT activity uniform is acceptable during all other activities.
- \*I will set a good example by being on time, prepared and participate in all scheduled programs as required.
- \*I will obey the safety rules and instructions of all supervisors and staff members.
- \*In consideration of other course participants and staff, I agree to follow the bedtime and sleep schedule of the course, unless otherwise directed by the course program.
- \*I will be responsible for keeping my tent and personal gear labeled, clean, and neat. I will adhere to all course recycling policies and regulations. I will do my share to prevent littering of the course grounds.
- \*I will demonstrate respect for unit and course property and be personally responsible for any loss, breakage, or vandalism of property as result on my actions.
- \*I will check items of value at the direction of course leaders. Neither the course leaders nor Central MN Council, BSA, will be responsible for loss, breakage, or theft of personal items. Theft will be grounds for expulsion.
- \*I will not possess tobacco, firearms, fireworks, weapons, alcoholic beverages or illegal drugs. Possession by youth will be grounds for expulsion.
- \*I understand hazing, bullying or any action that fails to show respect for an individual will not be tolerated.
- \*I understand cheating, stealing, dishonesty, swearing, fighting, and cursing, may result in expulsion from the course.
